

Assumption of Risks and Release from Liability

Above the Rim Sports, Inc. offers a variety of programs including, but not limited to camps, clinics, tournaments, sports team practices and games, physical training and strength/nutrition classes. Above the Rim Sports, Inc. takes pride in providing safe environments, equipment and programs, but by its nature, is not without risks. We do not want to diminish your enthusiasm for the experience, but we do want all participants to know in advance what to expect and what some of the potential risks are by participating in this activity.

Awareness of Risks: Although all individuals of average health will be able to comfortably participate, it shall be each individual's responsibility to be sure they are in a healthy condition. Participants who have heart ailments should understand that this activity might affect their condition. There are also the usual risks with this activity associated with being outdoors and having environmental exposures. Other risks associated with these activities include, but are not limited to: broken bones, muscle tears, sprains, heat exhaustion or heat stroke, allergic reactions, cuts, infections, mental anguish, or disabling head or spinal injuries.

Medical Treatment: In the event I cannot respond, I give permission for emergency medical, surgical and hospital treatment and procedures to be performed by a licensed physician or hospital, when deemed immediately necessary or advisable by a physician to safeguard my health. I agree to inform the staff person in charge about any special health conditions or medical needs, which may be affected by this activity. Emergency medical treatment is available at nearby hospitals.

Property Loss: I understand that Above the Rim Sports, Inc. is not responsible for personal property that is lost, damaged or stolen while participating in this activity.

Insurance: I understand it is my responsibility to provide for my own accident and health coverage while participating in this program and I further understand that Above the Rim Sports, Inc. does not provide this coverage. Participants are subject to their own family insurance, which is required.

Release from Liability: In consideration of being allowed to participate, I hereby agree to release Above the Rim Sports, Inc., its officers, directors, employees, volunteers or other agents from ordinary negligence, including liability for injury, illness, death, loss or damage resulting from participation in this activity.

Waiver Statement: I certify that my child has no injury which would limit his/her participation in program and has had a physical exam in the past year. I also authorize the director of the program to act for me in any emergency requiring medical attention. I hereby release, exonerate and discharge Above the Rim Sports, Inc., All: Park Districts, Recreation Departments, Sports Leagues, Schools, Sports Facilities, County's, and its employees from any or all actions or causes of actions, known or unknown, from any injuries incurred in program or on the way to the program. I have medical coverage and will be responsible for any medical or other charges related to his/her attendance at the program.

Photo Release: From time to time, ATR Sports may take photos, audio and/or video of my child for marketing purposes. I authorize ATR Sports, Inc to use this media in any way they deem necessary and waive any right to the photographs, video or audio.
